

A BYLAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS

- (1) J.T. Lauder Homestead - SW 28-20-20 W2
- (2) H. Miller Homestead - NE 22-19-22 W2
- (3) Forest United Church - Pt. NE 4-19-22 W2
- (4) Kennell Anglican Church - Pt. SW 27-20-20 W2
- (5) Foxliegh Anglican Church - Pt. NW 12-19-19 W2
- (6) Emmanuel Lutheran Church - Pt. SW 3-21-19 W2

AS BEING OF ARCHITECTURAL OR HISTORICAL VALUE

WHEREAS Part 111 of The Heritage Property Act, 1980, authorizes the council of a municipality to enact bylaws to designate real property, including all buildings and structures thereon, to be of architectural, historical or natural value or interest,

WHEREAS the Council of the Rural Municipality of Lumsden No. 189 has caused to be served on the owners of the lands and premises known as: (1) J.T. Lauder Homestead; (2) H. Miller Homestead; (3) Forest United Church; (4) Kennell Anglican Church; (5) Foxliegh Anglican Church; (6) Emmanuel Lutheran Church at: (1) SW 28-20-20 W2; (2) NE 22-19-22 W2; (3) Pt. NE 4-19-22 W2; (4) Pt. SW 27-20-20 W2; (5) Pt. NW 12-19-19 W2; (6) Pt. SW 3-21-19 W2 a notice of intention to so designate the aforesaid real property and has caused such Notice to be published in at least two issues of a newspaper with general circulation in the municipality with the first publication at least twenty-one (21) days prior to the date of consideration of the bylaw and with the last publication at least seven (7) days prior to the date of that consideration;

WHEREAS no Notice of Objection to the proposed designation has been served on the Secretary of the municipality;

THEREFORE, the Council of the Rural Municipality of Lumsden No. 189 enacts as follows:

- 1. There is designated as being of architectural and historical value or interest the real property known as: (1) J.T. Lauder Homestead; (2) H. Miller Homestead; (3) Forest United Church; (4) Kennell Anglican Church; (5) Foxliegh Anglican Church; (6) Emmanuel Lutheran Church and legally described as: (1) SW 28-20-20 W2; (2) NE 22-19-22 W2; (3) Pt. NE 4-19-22 W2; (4) Pt. SW 27-20-20 W2; (5) Pt. NW 12-19-19 W2; (6) Pt. SW 3-21-19 W2.

The Significance of the sites is as follows: (1) This is one of the oldest, stone, homestead houses left in this area; (2) Stone house and barn achitecture style from Eastern Canada (Ontario), built in 1902 and occupied by early Saskatchewan M.L.A. (H. Miller); (3, 4, 5 & 6) These buildings were used for worship services and social gatherings by the early settlers of this municipality.

2. The municipal secretary is hereby authorized to cause a certified copy of this bylaw to be registered against the property described above in the proper Land Titles Office.

3. The Secretary is hereby authorized to cause a copy of this bylaw to be served on the owner of the aforesaid property and on the Minister of Culture and Youth, and to cause notice of the passing of this bylaw.
