Entering into a development agreement with the RM to ensure the accessory dwelling unit will comply with all bylaw requirements, and that an interest based on the agreement shall be registered in the land registry against title to the subject lands at the applicant's cost pursuant to section 235 of *The Planning and Development Act.*"
