# **Clay Capping**

The Committee discussed that clay capping a road would only be considered after maintenance such as shoulder pulls and crowning have been performed.

Exit B was discussed. The Committee will request that the Public Works Department remove the grass from the shoulders of the road this year and plan to pull the shoulders in the spring of 2025.

#### **RM Shop**

The Committee discussed that the RM Shop should be located on a property larger than the current 3.9 acres. The Committee also discussed the advantages of moving to a more central location. Administration will bring back potential locations to the next meeting.

# **Traffic Counters**

The Committee discussed monitoring the traffic impacts of the new development on the south side of the Town of Lumsden. They requested that KGS attend an upcoming Public Works Committee Meeting to discuss traffic counting options.

# Director of Planning and Development, Aimee Bryck, joined the meeting via Zoom at 7:00 pm.

The Committee discussed the Civic Addressing System (CAS) progress and the need to name roads that do not fall on the numbered Township Road or Range Road grid system. Director of Planning and Development, Aimee Bryck, recommended the adoption of the Naming Municipal Roads Policy, in order to continue moving forward with addressing properties that are not located on numbered grid roads.

## **Road/Culvert Flags**

"That we recommend Council authorize administration to draft a policy to commence in 2025 for culvert markers be placed on newly installed culverts and culverts that are repaired." **CARRIED** 

# **Contracted Services Review**

The Committee discussed the contracted services for shoulder pulling that occurred in 2024. Going forward, the Committee would like to see the full scope of what services the contractor provides and what equipment and manpower will be required of the Public Works Department to supplement the work.

The Committee would like to bring this matter back to the next Public Works Committee Meeting to discuss a plan for contracting work in 2025.

#### Wascana Creek Erosion Control

"That we recommend Council pursue the Wascana Creek embankment armouring option rather than the Wascana Creek Realignment, due to the estimated cost of \$3,794,758.50 provided by our engineers, MPE." CARRIED

# **Dust Control**

The Committee discussed the 2024 dust control program and the large number of residents that participated. Concerns were discussed regarding the short amount of time allowed to prepare the various locations prior to dust control being applied. The Committee would like to hear comments from the Public Works Foreman on this year's expanded program.

# Bridge Weight Restrictions - Pense Grid and Trestle Road

Moved by: Councillor Division No. 6 Jordison

"That we recommend Council restrict the gross vehicle weight on the Pense Bridge and the Trestle Bridge to 20 tonnes, as recommended by WSP Canada Inc. and SARM, following their inspections; and, that administration coordinate the sharing of the new restriction information." **CARRIED** 

#### Road Closure Policy

"That we recommend Council adopt the "Temporary Road Closures Policy" attached as Schedule "A"; and,

That administration draft a policy for Temporary Road Closure Procedures."

#### Lumsden Beach Road

The Committee discussed adding roads in the Lumsden Beach area to the Road Plan; projects that are funded by the Road Reserve. Further discussion will be held to determine what work will best improve these specific roads.

#### **Speed Limits for Heavy Vehicles**

"That we recommend Council consider a speed reduction to 60 kms/hr through the entire municipality, for all vehicles over 10 tonnes." **DEFEATED**

#### **Microsealing Grid 734**

The Committee requested that administration investigate the benefits of microsealing Grid 734 and what options are available to extend its life.
