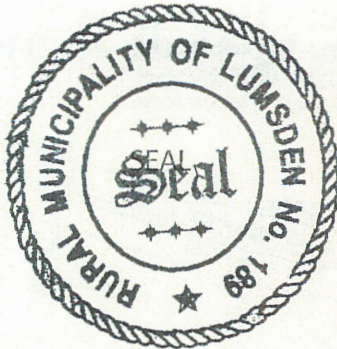
A bylaw to amend Bylaw No. 7-2012, known as the Zoning Bylaw of the Rural Municipality of Lumsden No. 189.

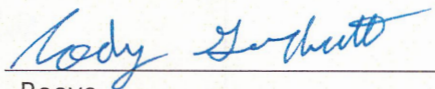
Pursuant to subsection 46(3) of *The Planning and Development Act, 2007* the RM of Lumsden No. 189 in the Province of Saskatchewan, by and with the advice and consent of the RM of Lumsden No. 189 Council, enacts to amend Bylaw No. 7-2012 as follows:

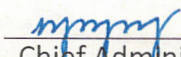
1. The Zoning District Map referred to in Section 5.2.1 is amended by rezoning a ± 4.955 ha (12.24 acres) portion of the land legally described as the NE $\frac{1}{4}$ 31-19-21-W2M and SE $\frac{1}{4}$ 31-19-21-W2M from the A – Agriculture District to the CR1 – Low Density Country Residential District as shown outlined in the bold black line on the attached map, which is attached hereto as Schedule “A” and forms part of this bylaw. The parcels are referred to as Lot 12, Block 1, Plan 102335790 and the future Lot 13.
2. This Bylaw shall come into force and take effect when approved by the Minister of Government Relations.

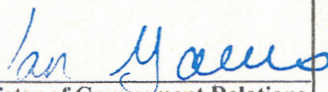

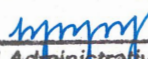
