BYLAW NO. 2026-06

A bylaw to amend Bylaw No. 7-2012, known as the Zoning Bylaw of the Rural Municipality of Lumsden No. 189.

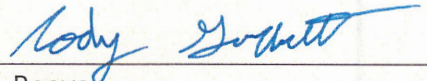
Pursuant to subsection 46(3) of *The Planning and Development Act, 2007* the RM of Lumsden No. 189 in the Province of Saskatchewan, by and with the advice and consent of the RM of Lumsden No. 189 Council, enacts to amend Bylaw No. 7-2012 as follows:

1. The Zoning District Map referred to in Section 5.2.1 is amended by rezoning a ±19.97 hectare (49.35 acre) portion of the land legally described as:
 - the NE ¼ 31-19-21-W2M Ext. 140
 - the NE ¼ 31-19-21-W2M Ext. 141
 - the NE ¼ 31-19-21-W2M Ext. 142; and
 - the SE ¼ 31-19-21-W2M Ext. 295from the A "Agriculture District" to the CR2 "Medium Density Country Residential District" as shown outlined on Schedule "A" attached to this bylaw.
2. This Bylaw shall come into force and take effect when approved by the Minister of Government Relations.
