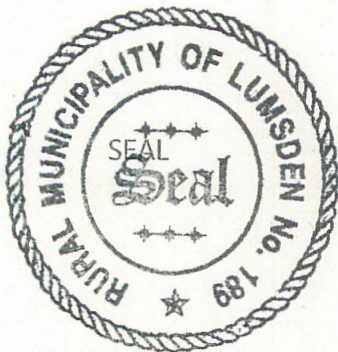
A bylaw to amend Bylaw No. 7-2012, known as the Zoning Bylaw of the Rural Municipality of Lumsden No. 189.

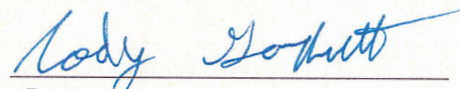
Pursuant to subsection 46(3) of *The Planning and Development Act, 2007* the RM of Lumsden No. 189 in the Province of Saskatchewan, by and with the advice and consent of the RM of Lumsden No. 189 Council, enacts to amend Bylaw No. 7-2012 as follows:

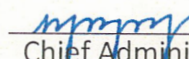
1. The Zoning District Map referred to in Section 5.2.1 is amended by rezoning a ± 1.01 hectare (2.50 acre) portion of the land legally described as SW $\frac{1}{4}$ 9-19-21-W2M from the A "Agriculture District" to the CR2 "Medium Density Country Residential District", as shown outlined in the bold dashed line on the Plan of Proposed Subdivision dated May 19, 2026 attached hereto as Schedule "A", and forms part of this bylaw.
2. This Bylaw shall come into force and take effect when approved by the Minister of Government Relations.

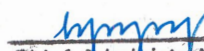

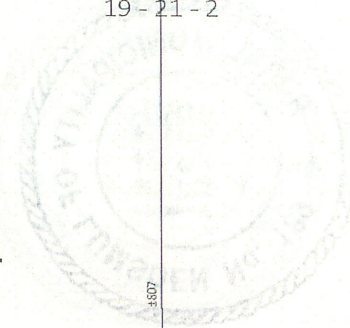
