### **Meeting Minutes**

#### **Public Hearing - Bylaw No. 2-2018 - Concept Plan June 14, 2018 - 2:00 pm**

The Rural Municipality of Lumsden Council convened the Zoning Bylaw Amendment Bylaw No. 2-2018 Public Hearing, on the afternoon of Thursday, June 14, 2018 at 2:00 p.m. at the Lumsden Municipal Office with Reeve Kent Farago presiding.

#### **Declare Public Hearing Open**

Reeve Farago opened the public hearing at 2:00 pm for the Bylaw No. 2-2018, a bylaw to amend the Official Community Plan Bylaw No. 6-2012.

#### **Administration Presents Background Information**

Development Officer Luke Grazier provided a verbal report on the purpose of the amendment.

#### **Presentations**

Reeve Farago invited any person who wished to make a presentation, to the council table.

##### Ivan Zubot:

- Confirmed his written submission was received
- Asked where the water will be supplied from and where the sewer will be stored
  - Community Planner, Luke Grazier responded that each property will have an individual septic tank and that the Grand Valley Development has secured water supply from the Town of Lumsden
- Asked if this matter was discussed prior to the meeting
  - Reeve, Kent Farago explained that these proposed subdivisions have been a work in progress for many years already

##### Bernie Felix:

- Stated he has lived in Lumsden for 30 years
- Has a concern with Developing 8th Avenue, due to it's current use by pedestrians
- Cautioned council about too much development. Suggested that development should only take place south of town, towards Regina

##### Louise Holloway:

- Stated she has lived in the Town of Lumsden since 1974 and was on Council for 10 years
- Has a concern with leaky septic systems
- Has a concern with slope instability
- Stated that Jack Mollard, a Geologist, provided a report from 1971 stating that building on the south-side of the valley is safe but the north-side of the valley must be planned carefully as it is prone to slumping.
- Has drainage concerns
- Has concerns that new lot owners will destroy parts of the existing ravines
- Has concerns with the density of the lots

Steve Croft:


- Asked where the water supply is coming from
  - Community Planner, Luke Grazier responded that a communal well is planned, and that the Town of Lumsden has allocated water to Grand Valley lots only
